Power Sharing:

Q1 What are your views on the ongoing IDAD lead peace process?

- 1. IGAD has failed to exclude Uganda from the negotiation peace process even though it has taken side on from this conflict
- 2. IGAD is not addressing the root causes of the conflict

- 4. All foreign forces must leave the territories of the Republic of South Sudan immediately
- 5. AU must investigate and brought to justice those who were responsible for carrying the genocide against the Nuer Nation members in Juba

Q11. Resources shall be mobilized in the following way: Part A and B

Part A

- 1. Fund raising events
- 2. Monthly financial contribution from the members and the friend of good will.
- 3. Mobilize finance, in kind donation; create small business that would generate small income for the movement.
- 4. Chairman of the finance and resources of mobilization committee should visit diaspora to mobilized people and resources.

Part B Management:

- 1. All funds should be directed to the account of the movement in Nairobi.
- 2. SSRRA should regularly updates, the contributors about their contributed funds received by the resource mobilization committee in Nairobi.
- 3. SSRRA staff in Diaspora to mobilize resources, donations, and none-food items
- 4. SSRRA office must be subjected to election.
- 5. The resources and mobilization committee should appoint financial expertise from the Diasporas.

- 2. Educate the public about the insecurity that the South Sudanese are facing under Salva Kiir's regime
- 3. Educate the public about SPLM/A's visions of the country

Q15. We endorsed the proposal to have President and the Prime Minister in the upcoming interim government of National Unity, however, we do not see the necessity of having three deputies for Prime Minister.

Q16. Our position on the proposal of the power sharing deal on the Prime Minister and the President's power remained the same.

**Q17:** We need two separate armies during the transitional period with equal powers and equal distribution of resources and training.

7. No disarmament for our non-military forces such as white army until the expiration of transitional period.

**Q19:** First SPLA/M is for peace but if IGAD failed to address the root causes, our forces will continue to defend and protect the targeted civilians.
