Republican Order No.27/2016 for the Formation of the National Dialogue Steering Committee, 2016 A.D.

1. TITLE AND COMMENCEMENT:

This Order shall be cited as "The Republican Order No.27/2016 for the Formation of the National Dialogue Steering Committee, 2016 A.D." and shall come into force on the date of its signature by the President of the Republic.
