Recommendations:

- 1. Established or restructure all the institution as per the R-ARCSS
- 2. All Commissions of Independent Institutions to have nine (9) Board Members unless pre-determined by the Agreement or the constitution as amended.
- 3. The Chairperson, Deputy Chairperson and Executive Secretary to be members of the Board except for the Bank of South Sudan, Insurance Regulatory Authority and National Audit Chamber.
- 4. The Executive Secretary will serve as the Rapporteur of the Board except for the Bank of South Sudan, Insurance Regulatory Authority and National Audit Chamber.
- 5. The Leadership of the Board shall be the Chairperson, Deputy Chairperson and the Rapporteur of the Board except for the Bank of South Sudan, Insurance Regulatory Authority and National Audit Chamber.
- 6. Each Institution shall have an Executive Secretary except for the Bank of South Sudan, Insurance Regulatory Authority and National Audit Chamber.
- 7. Any Commission or Independent Institutions established by the Constitution or Law, the board shall be stated in the Constitution or the Law.

N/B on OPP share based on the percentage notably 8% sharing, the allocations are as follow:

- 1. Allocation of five (5) shared of Chairpersons of our choices
- 2. Allocation of five (5) shared of Deputy Chairpersons
- 3. Allocation of five (5) shared of Executive Secretary
- 4. 64 members to all boards allocated
