

**THE SPLM/A-IO -WAAT Comprehensive Declaration to SSPDF;
Sector Three in Motot, Greater Lou Nuer,
Under the Command of Major General Michael Wal Nyak,
Sector Three (3) Commander.**

Declaration Statement.

Your Excellencies, Comrades in uniforms, intellectuals, business groups, white Army leadership, administrators, traditional leadership, youth and women of greater Lou Nuer in the struggle, the SPLM/A-IO -WAAT declaration is an Split of sector three comprises top Military Generals, junior officers and NCOs from three brigades of NYIROL, UROR and AKOBO predominantly deployed in MOTOT, Greater Lou Nuer, in 2013 as a result of civil wars in the Republic of South Sudan.

Excellencies, Comrades and Friends,

The SPLM/A-IO , sector three split under the command of Major General Michael Wal Nyak and the entire political wing would like to inform all comrades in uniforms, SPLM/IA-IO under Dr. Riek Machar Teny, the Vice President of the Republic of South Sudan, greater Lou Nuer sons and daughters in diaspora, traditional leadership, media houses, international community, youth and women fraternities that we have officially announced the Comprehensive Declaration and switch our allegiances to Sudan People Liberation Movement (SPLM) and South Sudan People's Defence Forces (SSPDF) under H.E. Gen. Salva Kiir Mayardit, President of the Republic, the Chairman of SPLM, C-in-of SSPDF, and supreme commander of organized forces.

The purpose and rationale of this comprehensive declaration triggered by myriads of concerns confronting service men and women, Lou Nuer citizens in the SPLM/A-IO compelled us to join the government. Those concerns aforementioned, are crystal clear to all comrades who have dedicated their time, resources in the SPLM/A-IO movement at it inception in 2013 civil wars.

Fellow comrades in uniforms, our pressing concerns are not limited to intentional humiliation and marginalization, lack of promotion and ranks confirmation of Greater Lou Nuer sons and daughters who sacrificed their lives to serve the movement that orchestrated by Dr. Riek Machar, the Chairman of the SPLM/A-IO Movement.

Dr. Riek Machar ignored and compromised the call for lucrative Ministry of Petroleum demanded by Lou Nuer political leaders, top military commanders, Youth leaders, women and traditional authorities all those attempts have gone in futile.

Fellow comrades, Lou Nuer politicians, sons and daughters are made only to serve at insignificant Ministry of Water Resources and Irrigation that does not compensate the tremendous contributions and commitment rendered to fight the government. The very great community of Lou Nuer people who are the powerhouse of the SPLM/A-IO Movement since the allocation of Lucrative Ministries in 2015-present no change of that Ministry as Lou Nuer expected.

Lou Nuer service men and women in sector three top military generals, junior officers and NCOs have never been promoted and non are assigned in the National Security and the consideration is given to people who claimed to be the right people to the corrupt leadership of Riek Machar. Dr. Riek Machar frequently used the SPLM/A-IO as his own family enterprise and personal movement that he does not heed the pressing concerns of people who offered their lives to sustain the SPLM/A-IO from 2013 and 2016 respectively.

Lou Nuer Community and comrades in uniforms,

Lou Nuer people are made to be an enemies of their neighbors and government of South Sudan to support only one family business not for all freedom fighters. Historically, Dr. Riek Machar ascends to top seat in Sudan and South Sudan struggle has been frequently supported by Greater Lou Nuer sons and daughters, with all resources and lives. more important instance is 1991, Nasir Declaration and again in 2013 when the country resorted to Civil Wars, and when the war ended, he forgot the concerted efforts made by Lou Nuer Community.

Lou Nuer sons lost their lives to support him with the hope for equitable services, shared equal opportunities and fair representation for all freedom fighters of different communities involved would be achieved. Dr. Riek Machar has been using Lou Nuer as hammer on the nails to achieve his political ambition.

Dr. Riek Machar made Lou Nuer areas as his stronghold to shield and harbor his abandoned soldiers who have no food, Uniforms, shelter, medicines and no promotion to the point their children are not going to schools. Some parents have never met again their children since the conflict erupted in 2013 due to lack of transportation. #

Riek Machar and his corrupt cohorts are still telling people, the root causes of conflict that engulfed the whole country in to civil war, poverty, lack of development, economic dwindle, social strife, poor health, inter-communal violence, high rate of illiteracy, lack of employment opportunities, political scuffle are not addressed.

Sector three comprises three brigades of Nyirol, Uror and Akobo that had engaged vehemently in wars for many years in Greater Lou Nuer areas with crucial reasons to achieve a just cause and equal opportunities for all citizens, service men and women extensively in all institutions' set up, but Dr. Riek Machar and his myopic cohorts failed to consider the promotion and confirmation of ranks we have been persistently battled to achieve.

Distinguished Community and Comrades in Uniforms,

Lou Nuer community remains backward due to lack of education for our children, lack of development, insecurity rampant, collapse of businesses and infectious diseases, no road, poor leadership and killing revenge of relative members This barbaric war that claimed lives and ferocious attacks based on political affiliation has to come to an end. It is time to unite and integrate ourselves with our brothers and sisters in the government, especially SSPDF and SPLM to build harmonious relations and build our Country.

The above mentioned challenges compelled us to join the government under Comrade Salva Kiir Mayardit to implement peace deal in letter and spirit. We will commence our training based on departments, ranks and arrangement for further integration of our forces in to SSPDF. We pledge to curb insecurity and criminals who exploit innocent children and civilian belongings. That arrangement will be done on timely schedule with Comrade. Salva Kiir Mayardit, C-in-C of SSPDF, chief of Defence forces, National Security Service, and all organized forces.


