### Ref: Response to Invitation for Jonglei State Intellectuals' Forum Meeting

Your Excellency,

Congratulations on your appointment and the trust bestowed upon you by the President of the Republic of South Sudan, H.E. President Salva Kiir Mayaradit. As you undertake the responsibility of leading Jonglei State, the Twic East Community extends its best wishes for a successful tenure characterized by inclusive participation and visionary actions to ensure the prosperity of our people and the state.

We are writing in response to a letter by Ustaz Ali Atem Diing, the Director General of the Jonglei State Coordination Office, circulating on social media, concerning a meeting scheduled for June 8<sup>th</sup>, 2024, at Palm Africa. The meeting aims to address the looming flood, oil exploration, and updates on ARC road construction. The list of invitees includes members from the Twic East, Duk, and Bor communities, which raises several important points:

- If this meeting is intended for Jonglei State Intellectuals, it should include representatives
  from both the Dinka and Nuer communities, reflecting the state's current administrative
  structure.
- 2. If the meeting is focused on Dinka Intellectuals within Jonglei, it should incorporate individuals from Bor, Twic, Duk, and Pigi counties.
- 3. As the governor, sworn to uphold the laws of the land, you are aware that the state's structure follows the hierarchy of Boma, Payam, County, and State.
- 4. Regarding the term "Greater Bor," the Twic East Community has, in conferences held in Juba on October 30<sup>th</sup>, 2022, and recently at Twic East Conference Panyangor from 10<sup>th</sup> to 13<sup>th</sup> March 2024, publicly denounced any association with this defunct and inactive

entity. We respectfully request that the Twic East Community not be invited under this umbrella.

- 5. The list of invitees from the Twic East Community does not comprehensively represent our intellectuals. Future engagements should involve our input to curate a more representative list.
- 6. Issues such as floods, oil exploration, and road construction affect all Dinka counties in Jonglei and many Nuer counties as well. Hence, the meeting should be more inclusive, participatory, and consultative.

The Twic East Community Conference in Panyangor has already discussed and provided resolutions on oil exploration, infrastructure development, and flood management. These resolutions, attached herewith, represent our community's stance, having been formulated with input from community leaders, chiefs, intellectuals, political figures, youth, women, and diaspora representatives.

Our community respects the current governmental structure from Boma to State and recognizes the distinct identities of the Nuer and Dinka in different counties. The concept of "Greater Bor" has become obsolete with the creation of additional counties. Since the BMC meeting on October 30<sup>th</sup>, 2022, and the Twic East Community Conference from 10<sup>th</sup> to 13<sup>th</sup> March 2024, the Twic East Community ceased to recognize or participate in gatherings under that name.

Nevertheless, the Twic East Community remains committed to the unity of the Dinka in Jonglei's Pigi, Duk, Twic, and Bor counties, as well as the unity between the Dinka and Nuer communities within Jonglei State. We believe unity must be reflected in our words and deeds.
